2.1 Unit Descriptor

In this unit, students will be required to complete 100 hours of person-to-person (including opportunity for alternatives modes of counselling including video and phone) counselling over one semester. Student learning will be guided by regular one-on-one and small group supervision, including case conferencing. These forms of supervision will support students to enrich their ethical counselling practice and to develop a deeper understanding of themselves as counselling), write case notes using the SOAP format; make client bookings and manage client loads; manage client records, counselling logs, supervision logs; make referrals where necessary, and ethically and appropriately manage client information.

2.2 Learning Outcomes for Unit

Learning outcomes for unit:

- 1. Address the idiosyncratic nature of a client's need through intentional, theoretically informed, ethically and culturally aware counselling practice and/or informed referral pathways.
- 2. Demonstrate intentional and appropriate use of self and counselling skills in the counselling process, with a focus on creating a safe and helpful therapeutic alliance.
- 3. Ethically communicate theoretical propositions, conclusions and professional decisions to the client, peers, and other professionals where required.
- 4. Write concise case notes using the SOAP format, demonstrating advanced communication skills.
- 5. Cultivate, through regular supervision, a growing level of personal awareness, autonomy, ethical application, and accountability in their counselling practice.
