SECTION 2 – ACADEMIC DETAILS

2.1 Unit Descriptor

Provide below a brief unit description, which includes a summary of the key content of the unit.

This unit introduces students to a range of psychological disorders, assisting them to gain an understanding of their aetiology, characteristics, and accompanying issues. It is informed by a multidimensional perspective of causality and treatment of mental illness that promotes the practice of intentionally identifying needs specific to each individual. This approach aims to foster the development of a compassionate and non-judgemental viewpoint and challenge students' own pre-conceived notions around the role of stigma. Students will be encouraged to think critically about the nuances of mental health presentations in context, to recognise the signs of psychological problems, preparing them to discern how to provide appropriate therapeutic assistance to facilitate optimal functioning and wellbeing.

2.2 Learning Outcomes for the Unit

Learning outcomes for unit:

1. Differentiate clinically relevant mental health presentations.
2. Explain the biopsychosocial, spiritual and cultural factors impacting the development, symptoms, and treatment of clients with mental illness and their families.
3. Critically appraise treatment options that address the neurological/physiological, psycho-cognitive, social, and cultural aspects of mental health, in order to formulate strategies for clinical counselling practice and possible referral sources for extra support.
4. Critically reflect on personal mental health and wellbeing.
