SECTION 2 – ACADEMIC DETAILS

Brief description of the content of the unit (key topics):

This unit introduces students to pastoral counselling, its biblical and theological basis, the theoretical frameworks in which it is practiced, and recent scholarship in the field. *Introduction to Pastoral Counselling* is designed to equip students with the knowledge and dispositions that will be foundational for their practice as pastoral counsellors, enabling them to engage in this practice in diverse ministry settings in a spiritually formed, theoretically grounded, and ethically sensitive manner. Key topics covered include: contemporary pastoral counselling theories, ethical considerations, biblical and theological themes that undergird pastoral counselling, the distinction between “counselling” and “pastoral counselling”, and the spiritual dynamics of pastoral counselling.

Learning outcomes for unit:

- 1) Explain the nature and scope, biblical/theological basis, and spiritual dynamics of pastoral counseling with reference to the biblical text, the Christian tradition, and contemporary scholarship
- 2) Investigate the differences between the field of pastoral counselling and counselling
- 3) Evaluate key features, strengths, and weaknesses of contemporary theoretical approaches to pastoral counselling
- 4) Respond to complex client issues and challenges that occur in pastoral contexts by responsibly employing sound pastoral counselling theories and assessing when and where to make client referrals

1) Oral Presentation Students present a theological reflection upon the biblical/theological basis of pastoral counselling and use this to illuminate a significant experience of giving and/or receiving pastoral counselling. (1,000 words equivalent)	1	Week 4	20%
2) Short Essay Students are to write an essay explaining the difference between counselling and pastoral counselling and the significance this has for their role as pastoral counsellors. (1,000 words equivalent)	2	Week 7	20%
3) Case Studies Students are to write a response to a case study that presents a particular pastoral counselling situation. Their response should be grounded in sound pastoral counselling scholarship and adhere to the relevant ethical guidelines. (1,500 words – 500 words each)	1, 4	Week 10	25%
4) Major Essay Students are to write a major essay that assesses a pastoral counselling theory, critiquing its theological implications and personal application. (2,000 words)	1, 3	Week 13	35%
