This unit examines the history and development of counselling theory and explores five counselling schools of thought: Psychodynamic, Cognitive-Behavioural, Humanistic, Postmodern, and Systemic. It also considers Christian approaches and considers theoretical implications for social and cultural diversity.

The aim is to help students recognise strengths and weaknesses in each approach by examining philosophies, processes, and techniques. The approaches studied are by no means exhaustive but are sufficient to introduce students to developing a personal working philosophy and theoretical framework. Comparisons of the philosophies include their perspectives on human nature, psychopathology and the process of change, and are made with worldview and Biblical foundations learned in previous units.

Learning Outcomes for Unit**Learning outcomes for unit:**

1. Discuss five key counselling philosophical schools of thought, including their perspectives on human nature, psychopathology and the process of change.
2. Review counselling theoretical perspectives in light of the theological standpoints, cultural and social diversity, therapist position of power and clinical efficacy.
3. Apply theoretical knowledge through personal application and case specific contexts as a bridge to integrative counselling practice.
