Key topics include: the historical and theological roots of the Christian tradition / denomination; key formative people and documents; key beliefs and features; contemporary church practice (including governance); and the future of the tradition / denomination.

- (1) Explain the historical and theological roots of their Christian tradition, including an awareness of major formative events, documents and significant people
- (2) Articulate the key beliefs and features (including polity) of their Christian tradition in a clear and coherent fashion
- (3) Analyse contemporary church practices (including governance) in light of their tradition's history, theology and current cultural context
